RESOLUTION
Adopt and Enforce the
Hamilton Township Fire Chiefs' Association's
Standard Operational Guidelines

Whereas, There has been a long standing need to standardize the fire, rescue, and emergency medical services operations within Hamilton Township; and

Whereas, It is recognized that the Hamilton Township Fire Chiefs' Association consists of the elected volunteer fire chiefs and the promoted career fire chiefs of Hamilton Township, who collectively are the senior fire officers and leaders of the firefighting forces within Hamilton Township, and

Whereas, The Hamilton Township Fire Chiefs' Association has established Standard Operational Guidelines (SOG's) for all volunteer and career personnel to follow during emergency operations. The established SOG's are designed to provide efficient, effective, and safe fire protection, motor vehicle and technical rescue services and, in some cases, first responder emergency medical services to the citizens and visitors of Hamilton Township, and


Whereas, The Established SOG's shall be reviewed by the SOG Committee at least annually and any changes to existing SOG's or new SOG's will be presented to the Boards as needed for their adoptions, and

Whereas, The undersigned, representing the Board of Fire Commissioners of Fire District No. 3 of Hamilton Township, County of Mercer, State of New Jersey, desire to support the Hamilton Township Fire Chiefs' Association and their Standard Operational Guidelines.


