RESOLUTION: AUTHORIZING THE SALE OF A 2005 SEAGRAVE 100' AERIAL LADDER TRUCK KNOWN AS TRUCK 13 TO THE CITY OF TRENTON, COUNTY OF MERCER, STATE OF NEW JERSEY

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF FIRE DISTRICT NO. 3 IN HAMILTION TOWNSHIP, COUNTY OF MERCER, STATE OF NEW JERSEY

WHEREAS, Hamilton Township Fire District No. 3 ("HTFD 3") owns a 2005 Seagrave 100' Aerial Ladder Truck, known as Truck 13, bearing VIN# 1F9FE38JX5CST2074; and

WHEREAS, Hamilton Township Fire District No.3, such that there will be no further public use of Truck 13; and

WHEREAS, HTFD 3 now wishes to sell Truck 13, which is public property; and

WHEREAS, HTFD 3, pursuant to N.J.S.A. 40A:11-36, may by Resolution and without advertising for bids, sell its personal property to any governmental unit in the United States; and

WHEREAS, the City of Trenton is a municipal entity located in the County of Mercer, State of New Jersey; and

WHEREAS, the Fire Director of the City of Trenton Department of Fire & Emergency Services, pursuant to the authorization by the City of Trenton's City Council, has provided HTFD 3 with a letter of intent, dated November 17, 2016, to purchase the 2005 Seagrave 100' Aerial Ladder Truck, knowns as Truck 13, for the purchase price of \$150,000.00; and

WHEREAS, the Board of Fire Commissioners of HTFD 3 desires to sell Truck 13;

NOW, THEREFORE BE IT RESOLVED, by the Board of Fire Commissioners at an open public meeting held on December 12, 2016 that HTFD 3 is authorized to sell Truck 13 bearing VIN# 1F9FE38JX5CST2074 to the City of Trenton, County of Mercer, State of New Jersey for the purchase price of \$150,000.00 in accordance with N.J.S.A. 40A:11-36 with the proceeds of

the sale going directly to HTFD 3, to be earmarked for the unrestricted fund, to be used for property tax relief.
